The meeting began with the brief of Hon'ble Vice Chancellor. He briefed about QS I-Gauge rating participation and elaborated on the meaning of Rating, Ranking Accreditation and Recognition as markers of quality.

He mentioned the need to re-frame the vision 2030 document and name it as the MGMIHS Vision 2035 document. The guidelines for the same will be discussed in the upcoming University IQAC meeting.

Dr. P. M. Jadhav, Vice chairman MGM trust, mentioned the need for sensitization of all the stakeholders of MGMIHS regarding the QS I-Gauge rating.

He said that we need to work on the International collaborations and make the MOUs active. We need to improve on our research activities before involving ourselves in such ranking or rating activities.

He also mentioned that we needed to put in more efforts to sensitize all the stakeholders regarding the process and the importance of it with clear instructions.

He mentioned the need of JCI accreditation, Dr. Nitin Kadam said that JCI is mainly for the hospital accreditation though they have an academic aspect as well, which requires a lot of preparation from the institute

Hon'ble Vice Chancellor mentioned that participation in QS I Gauge rating is a step towards the international ranking system, this will create awareness of how to plan for the future international ranking

He mentioned that the IQAC coordinator has an important role and when assigned a task the Heads of the Institutes must support the IQAC Coordinator and give them time, guidance and support to accomplish the task, Else it will be challenging to sustain NAAC A++

Dr Nitin Kadam mentioned the improvement in infrastructure is needed

Hon'ble Vice Chancellor directed the University IQAC coordinator to present the draft report of QS I-Gauge.

The IQAC coordinator began the presentation of QS I-Gauge data of units. The period of QS I Gauge rating for MGMIHS was mentioned. The data of the AQAR 2021-22 was used. The screenshots of the QS I Gauge portal were displayed.

The presentation of the core criteria and the advanced criteria data templates were made. Links for the evidences were opened to show the compiled data

Core Criteria- Employability

There was discussion to include extracurricular activities for students to help them become easily employable

Dr. Goel, Registrar, MGMIIIS, said that we need to have activities to help the students prepare an excellent CV, personality development, good communication skills and how to present yourself at the interviews etc.

Dr Nitin Kadam Pro vice chancellor mentioned that basic foreign languages should be taught to enrich the students and give them more scope. Also, there was discussion of helping the students and guiding them for the post graduate exams and for the international license exams

Core Criteria- Diversity and Accessibility

Regarding the international faculty and students

It was mentioned that there is a list at the University regarding the international faculty who regularly come for talks and can be included as International faculty. Their appointment letters and ID cards can be collected from the university.

There was a mention about the students in the psychiatry and surgery department who come for observership from different countries

Core Criteria- Facilities

There was mention of having the anti-suicidal fans by Dr. Nitin Kadam Pro Vice Chancellor. Dr.Uttara Deshmukh, Incharge UDPO, MGMIHS, mentioned about using the tiles which would support the blind persons . All the higher authorities appreciated the suggestion and it was noted to make the change

Core Criteria -Social responsibility

Hon'ble Vice Chancellor mentioned that the Unnat Bharat Abhiyan activities, tree plantation activity and Green Mentor Award that we received from Hyderabad must be mentioned. Dr.Nitin Kadam Pro Vice Chancellor said that many students are working for NGOs. Dr Rita Khadkikar mentioned that they do it at their personal level and the documents are not submitted to the institute. We need to sensitize the students and ask them to submit the data and support them for the same

Advanced Criteria - Research

Our in house indexed journal details were displayed

There was a discussion that the MGM Dental college was publishing the journals quarterly in collaboration with MGM Institute of Health Sciences hence we have to include that as a second journal. Dr Goel mentioned that we would be able to score only if we had 2 or more in house journals that are indexed.

Advanced Criteria - Academic Development

There was a discussion to show all the senior members in different administrative bodies within the college and outside MGMIHS.
